
## **INSTRUCTIONS :**

### **According to Bye-law Provision (5) and (10) of Vishwakarma Welfare Association Executive Committee Members - 05 Posts should be selected.**

1. Candidates should submit their Nominations to Election Officer or any person, authorized by Election Officer.
2. Nomination Papers will be accepted in prescribed format given by Election Officer.
3. Minimum Quorum is compulsory to conduct Office Bearers election proceedings.
4. If the proposer proposes more than one Candidate, the Nomination of such candidate shall stand rejected.
5. Any Candidate willing to withdraw from Election, they should come personally and hand it over to Election Officer.
6. If the Eligible Nomination forms exceeds the required Office Bearers post election will be conducted with Secret Balloting paper.
7. During Election polling date, Executive Committee Directors should personally come and cast their Votes. Proxy votes and postal ballot votes are prohibited.
8. If the candidates secure equal Votes, the lottery will be done to decide the office bearer post.
9. Any Queries/ Clarification regarding Election, decision of the Election Officer will be final.
